- Commuter Challenge Subcommittee
 - N. Cannon referred to the notes taken from the Commuter Challenge 2021 Sub Committee meeting that were included in the packet and shared improvements the subcommittee has recommended for the 2021 event
- Bike Month
 - Wilmington Area “Bike There” Map
 - N. Cannon shared with the committee that the Wilmington Area “Bike There” Map is complete and online and available in print
